

## ***TERMS AND CONDITIONS OF ENROLMENT:***

- 1) I, the undersigned member (or guardian on behalf of the member) hereby enrolls as a member of JKA Karate Unlimited and/or Jiu-Jitsu Unlimited and/or Mix Martial Arts (MMA) Unlimited and/or Self Defense Unlimited for training online or at the clubs, for a fee as agreed upon, per month payable in advance.
- 2) I agree that my membership will be for a minimum duration / period of six (6) months.
- 3) I understand that this agreement cannot be cancelled before the minimum duration / period has expired. I also understand that this agreement will continue after the minimum duration / period has expired on a monthly basis until I give notice of cancellation.
- 4) A notice of cancellation form supplied by JKA Karate Unlimited and/or Jiu-Jitsu Unlimited and /or Self Defense Unlimited must be filled in and signed and handed in or emailed, to give written notice of my intent to cancel this agreement on the expiry duration / period must be received by the head instructor Riaan La Grange by no later than thirty (30) days prior to the debit date of the final amount payable.
- 5) Should such notification not be received by the head instructor Riaan La Grange, this agreement shall continue to be of force and effect after the minimum duration / period and shall then be terminable only after one (1) months' notice of cancellation form supplied by JKA Karate Unlimited and/or Jiu-Jitsu Unlimited and /or Self Defense Unlimited was filled in, signed handed in or Emailed.
- 6) The cancellation of membership form supplied by JKA Karate Unlimited and/or Jiu-Jitsu Unlimited and /or Self Defense Unlimited has to be filled in, signed and handed in or Emailed, should you wish to terminate your membership, the member/s cancellation is subject to 1 (one) month notice in advance. I acknowledge that fees will be due and payable for the cancellation month. Please note no other form/media format, other than the cancellation form supplied by JKA Karate Unlimited and/or Jiu-Jitsu Unlimited and /or Self Defense Unlimited will be accepted as notice of cancellation of membership.
- 7) Termination of my membership in the month of October shall be subject to a written notice. I acknowledge that fees will be due and payable for the month of October, November and December.
- 8) I agree that I will be liable for my fees despite the fact that I do not attend the training, until the expiration of my membership.
- 9) Should you terminate your membership for ANY reason (health, injuries, work, and financial difficulties) and have paid the yearly registration / affiliation to JKA Karate Unlimited and/or Jiu-Jitsu Unlimited and /or Self Defense Unlimited, then wish to reinstate your membership you will be liable and will have to pay the registration fee again.
- 10) Fees are based on a twelve (12) month period.
- 11) I further agree to an annual increase of my monthly premium. I further agree to an annual affiliation / registration fee with an annual increase payable on the first day of the second month (1st of February) of every calendar year.
- 12) Should any amount fall due, due to a returned debit order or electronic transfer of funds or cash payment, the following amount will include all arrears and related costs. Should two consecutive payments be returned or not be paid, full value of this membership contract will fall due and collection / legal proceedings will commence, as this agreement is legal and binding. All related costs in the legal and collection proceedings will be borne by the undersigned.
